**ORDER**

In accordance with clarification issued by Services Department (Services-I Branch), Govt. of NCT of Delhi vide letter No. 20/17/2015/S-I/Lit./2938 dated 25.08.2015 & Note 10 below Rule-7 of CCS(Revised Pay) Rules, 2008, sanction of the Spl. Secretary (Finance)/Head of Department is hereby conveyed for stepping up of pay of **Ms. Urmila Bali, Stenographer Grade-II** [Seniority No. 1485 (as Grade-III) and 474 (as Grade-II)] at par with her junior counterpart **Ms. Sushma Bisht, Steno. Grade-II** [Seniority No. 1615 (as Grade-III) and 555 (as Grade-II)] at the stage of ₹ 13860+4600 as on 03.01.2006 and her pay is regularized accordingly as per CCS(Revised Pay) Rules- 2008, as under: -

It is further certified that: -

- (i) Both the junior and the senior Government servants belong to the same cadre and the posts in which they have been promoted/financially upgraded are Identical in the same cadre.
- (ii) The pre- revised scale of pay and the revised grade pay of the lower and higher posts in which they are entitled to draw pay are identical.
- (iii) The senior Government servant was drawing more pay than the junior before receiving financial upgradation under ACP Scheme.
