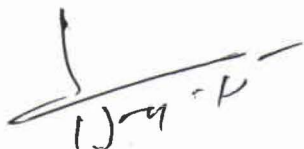

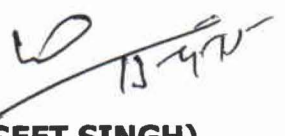

However, the fixation of pay is further subject to audit observation & recovery of over payment, if any, which may be detected at a later stage.

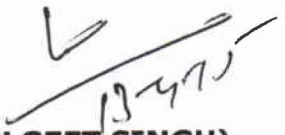
