This is regarding the simplification of procedure for securing annual "Life Certificate", for the purpose of disbursement of pension to a very large number of pensioners, by using digital medium.

- As per the extant procedure, a Pensioner is required to either personally present himself/ herself before the Pension Disbursing Agency or have the Life Certificate issued by one of the authorities notified for the purpose and have the same delivered to the said Disbursing Agency during the month of November every year. This causes hardship particularly to those who are aged and/or infirm Pensioners. Besides, the existing system is prone to misuse by way of fraudulent withdrawals causing loss to the exchequer.
- In view of the above, the Department of Electronics & IT, Ministry of Communications & IT, Government of India has developed "Jeevan Pramaan -Digital Life Certificate" Portal (jeevanpramaan.gov.in), which was launched by Hon'ble Prime Minister on 10th November, 2014. A copy of the brochure and a note on the process is enclosed for your reference.
- I may mention that the Controller General of Accounts (CGA), Government of India, has since issued necessary instructions through the enclosed Correction Slip No. 22 in the Scheme for Payment of Pensions, for accepting the Life Certificate issued online by a Government Agency as a result of Aadhaar Biometric Suthentication as a valid certificate, in respect of Central Government Pensioners.
 - Considering the benefits available from this Portal, I am desired to request you to:

appropriately notify amendments to the relevant Rules/ Instructions in (i) your State on the lines issued by CGA; and

sensitize the concerned Pension Disbursing Agencies in the State as well as the State Pensioners about the procedure for online submission of Digital Life Certificate and its retrieval from a Central Digital Repository in NIC.

Process of getting digital life certificate issued for Pensioners



- Step 1: Pensioner needs to have an Aadhaar number for getting digital Life certificate issued.
- Step 2 : Pensioner needs to enrol and biometrically authenticate himself/herself using one of the following methods
 - a) Download application prepared for generating digital life certificate from jeevanpramaan.gov.in on any Android Tablet/Smartphone or Windows PC. Procure a low cost finger print scanner/iris scanner from the market and plug it on USB port of the Tablet/Smartphone/PC. Using the above application, Pensioner will be able to enrol and bio-metrically authenticate in real time from the comfort of their homes by giving his/her Aadhaar number and other details related to their pension bank account.
 - b) Pensioner can visit a nearby CSC center, Bank Branch or any Government office whose details are provided under "locate center" on jeevanpramaan.gov.in and bio-metrically authenticate in real time by giving his/her Aadhaar number and other pension details related to their pension bank account.
 - c) If the pensioner is already enrolled on the system, next time he gives his

 Aadhaar number, he would only be required to authenticate his bio-metric for
 updating date of his digital life certificate.
- Step 3 : After successful submission of digital life certificate, pensioner will be sent a sms on his/her mobile giving the transaction id. Pensioner will be able to download computer generated life certificate from jeevanpramaan.gov.in using this transaction id for their records.
- Step 4: Bank Branch can be informed about submission of your digital life certificate in one of the following ways
 - a) Bank can login on jeevan parmaan.gov.in and can search manually for Pensioner's life certificate either by giving Aadhaar number, Bank Account number or Transaction Id
 - Core Banking Systems of Banks will be able to automatically download life certificate details from the digital life registration repository and update life status in Pensioner's bank account.
 - c) Pensioner's digital Life certificate can be sent to respective branch of the Bank by sending an email or forwarding the link through sms to download life certificate from the website.

Reminders through sms will be sent to the pensioners enrolled on jeevanpramaan.gov.in for timely submission of their digital life certificates.

A software application is being developed both on Windows and Android platforms for all devices that would enable the following to conclusively establish that the pensioner was alive at the time of biometric authentication:


- Register the pensioner's Aadhaar Number and biometric details from PCs or other devices using biometric reading device;
- Authenticate the pensioner through UIDAI's Central Identities Data Repository (CIDR) using biometric details and fetch his / her photograph and other demographic details on successful authentication;
- Upload details such as date, time, biometrics, device ID for each pensioner in the Database on a real time basis;

iv Expose an API that would enable any agency to secure authentication details or facilitate obtaining authentication information.

This facility is proposed to be made available at the Common Service Centres (CSC) being operated under National e-Governance Plan, particularly for the benefit of pensioners residing in remote and inaccessible areas.

Benefits of the Digital Life Certificate

- Application can be replicated to all pensiondisbursing authorities.
- Simple and easy to implement.
- Circumvent difficulties involved in production of Life Certificate every year.
- Reduce chances of wrongful disbursal of pension.
- Inexpensive, scalable and cloud based application.
